1. 2. Overdue, unpaid amounts are subject to the greater of a service charge of ten USD (\$10.00) or 1.5% per month of the unpaid amount, subject to legal maximums. If payment is overdue more than the grace period we allow, in addition to our other rights, we may suspend your use of any Credit Pack and/or your Authorized Purchaser's ability Download Content. If the failure continues for 14 days after written (could be by email) notice, or you fail to cure any other material breach of this Agreement within 14 days of written notice of the breach, or you are subject to an insolvency or bankruptcy event, then we may terminate this Agreement and/or your Authorized Purchasers' Pond5 account and/or ability to Download Content hereunder. You will have no right of set-off and all amounts due hereunder shall be due regardless of any claim by you against us.
